IMPORTANT INFORMATION

- The candidate must be a citizen of India.
- The qualification prescribed for each Post will only be considered. Equivalent qualification will not be considered.
- Relaxation in Maximum Age Limit: SC(5 Years), ST(5 Years), OBC(3 Years), PH(10 Years). The Upper Age Limit prescribed shall not be applicable to the regular employees of the Institute.
- The crucial date for determining the age limit is 1-1-2019.
- 1 Post of LDC is reserved for Physically Handicapped (One Leg), 2 Posts of Staff Nurse are reserved for Physically Handicapped (One Leg) and 3 Posts of Multi Tasking Staff are reserved for Physically Handicapped (1 post for Hearing Impairment, 1 post for One Arm and 1 post for One Leg).
- The Pay Scales carry usual Allowances admissible as per Central Government Rules and applicable to the Institute.
- The New Pension Scheme of the Government of India is applicable in the Institute.
- The Cast Certificate should be in the manner and Form prescribed by the Government of India.
- Candidates already in Govt. Service must send their Application Through Proper Channel. However an Advance Copy may be sent which must reach by the Closing Date.
- No Personal Interview will be conducted for Selection to the above Posts.
- An Objective-Type Written Test will be conducted for all the above Posts for drawing Merit for Selection. The Test shall be of 100 Multiple Choice Questions carrying 100 Marks and of 1½ hours duration. 1 Mark will be awarded for each Correct Answer while ½ Mark will be deducted for each Wrong Answer. The Syllabus for the Written Test will be posted on the Institute Website shortly. Candidates may watch for the same.
- Selection to the Posts of Pharmacist(Ayurveda), Staff Nurse(Ayurveda) and MTS will be based on the Merit of the Written (Screening) Test.
- For the Posts of LDC, 5 Candidates for each Post will be shortlisted from the Merit of the Written (Screening) Test. Such shortlisted Candidates will be called for a Typing Test on Computers and the Final Merit will be drawn on the basis of the Marks obtained in the Written(Screening) Test as well as the Typing Test. The Date, Venue etc. for the Typing Test will be intimated to such Shortlisted Candidates separately.

14. An Application Fee of Rs. 2000 (Rs. 1600 for SC and ST Candidates) for the Posts of Pharmacist, Staff Nurse and LDC and Rs. 1800 (Rs. 1400 for SC and ST Candidates) for the Post of MTS by DD in favour of "Director, National Institute of Ayurveda, Jaipur" should be enclosed with the Application for each Post. Separate Application along with the prescribed Fees must be submitted in case a candidate is applying for more than one category of Post.
